According to § 17 RGPD, the data subject may at any time request **the rectification, deletion and blocking** of personal data to the Data Controller.

Furthermore, the data subject may exercise his **right to object** at any time without stating the reasons and modify or revoke the declaration of consent provided with effect for the future.
